Financial

Common Facility Centre offers:

Facilities in terms of training, packaging, and basic testing activities – it will help cluster firms to tap local, regional national and global demand premium quality of spices and pickles. The CFC is envisaged as one that will facilitate competitive orientation of cluster firms and help them offer quality products competitively. There is scope for directly accessing growing demand of PET bottles in the cluster and nearby districts such as Nogaon, Kamrup and Nalbari. The major products that are processed in the cluster are pickles (mixed, mango, chili and Bamboo shoots). The spices include turmeric, chili, cumin seed powder. Apart from these, jam, jelly and sauces are also processed and marketed in the district. CFC would serve:

- ❖ Facilitating cluster firms to progressively cater to Pickle and Spice market segments and expand product and market mix.
- Enhancing manpower skill development and upgrading facilities.
- Ensuring competitive market orientation of cluster firms
- Enabling higher quality cost competitiveness particularly vis-à-vis packaging quality and establishment of premium Pickle and Spice markets
- ❖ Add value to services and products offered by cluster firms.
- Increasing capacity utilization of firms through expanding the market and in turn contributing to additional employment generation in the state.

Implementing Mechanism - Formation of Special Purpose Vehicle (SPV)

The project is to be implemented on public-private partnership scheme through an SPV M/s "Morigaon Integrated Fruits and Vegetables Industry Pvt. Ltd." The entity is incorporated under the Companies Act, 1956 with 35 shareholders (mainly from the F&V processing sector) and with an authorized capital of Rs.63.31 lakhs. The SPV invested 20% of equity capital and have received 80% grant from the APART Project of Govt. of Assam.





Machinery interventions in the CFC

- PET Bottles processing unit with 800 bottles per hour capacity (2 no) with mold size from 100, 200, 250, 500 and 100 gm/ml
- Pouch filling sealing machine (2 no) for paste type pickle individual (Mechanical Type) 2 to 10 gm, and 50 to 100 gm
- Jar filling & induction sealing manual types 100-250 gm (4 no)
- Standee Pouch Manual Filling & Bench Sealing: semi-automatic (4 no).
- Cutting, packaging, table & stool etc.
- Grinder machine 2 sets with a production capacity of 60 kgs per hour
- SS table for packaging
- Impact Pulverizer / Grinder of 200 kg/hour (3 no), and 60 kg/hour (2 no)
- For spices pouch filling and Sealing machine of 2 to 10 gm (2 no) and 50, 100 & 250 gm (2 no)
- Cold storage: 10 MT capacity.
- Testing Lab with Basic Testing Equipment's for Testing of Fruit & Spices

Project Benefits:

- This turnover is expected to rise at least by 30% after operationalization of the CFC.
- The envisaged common facility will help existing firms move up the value-chain; help expand product and market mix (better standardized products, better packaging, Value Addition).
- Enable increase in employment by at least about 200 persons directly; train manpower to the tune of at least 350 persons in 5 years.
- Profit margins may double from 10% to 20%.
- Some of the larger firms could invest in related (envisaged CFC) equipment through demonstration effect of the project helping up-scale impact.
